## CRC Update RMLV Course

From the 1st January 2009 RMLV certification will be required by all "Approved Managers" under the new legislation. This program is designed to ensure that Approved Managers (and other industry participants) receive information about their obligations under the Liquor Act. In the RMLV course, some of the elements in the RSA course are covered; however to receive the Liquor Licensing Division Approved RSA qualification, you must complete this course separately. We can arrange in-house RSA training at your venue for a reduced group price or you can attend RSA Training at the College when they are scheduled.
